*The FlaSEIA Solar & Storage Photo Awards program will*

- Recognize and reward innovative design and planning
- Expand solar and storage industry awareness to Floridians.
- Provide FlaSEIA members a method for promoting their product by using this competition as a marketing opportunity.
- Stimulate the installation of attractive solar and storage in residential and commercial environments.

#### ELIGIBILITY

Current members of the Florida Solar Energy Industries Association (FlaSEIA) are eligible to submit entries to the contest. The licensed Florida contractor who received payment for the installation is eligible to receive the award. Submissions are accepted from March 1, 2023 – March 31, 2023. By submitting an entry, each contestant agrees to the rules of the contest and states that he or she is 18 years or older.

#### AGREEMENT TO RULES

By participating, the Competitor (“You”) agrees to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of FlaSEIA as final and binding as it relates to the content of this Contest.

#### WHAT TO ENTER

You should submit photos of residential or commercial systems You have installed in Florida. Ideal submissions include photographs of the system from multiple angles and viewpoints. Photos with people visible do not qualify.

#### HOW TO ENTER

Please submit photographs and requested entry information online at [www.flaseia.org/summit/flaseia-awards](http://www.flaseia.org/summit/flaseia-awards). You may enter as many submissions as You like. Photographs (each a “Photo”) should be in .jpeg, .jpg, or .png formats and at least a resolution of 300 dpi. Each photograph will be accompanied by the following information within the form: 1) Residential or Commercial, 2) Installer Name, 4) City and State of Project, 5) Size of System (kW), 6) Other Distinguishing Characteristics, 7) Interconnection Date, 8) Installer Contact Information.

#### JUDGING

Photo entries will be judged by an independent panel based on quality, visual appeal of the surroundings, and clarity of the image. FlaSEIA will award 5 prizes. You may win multiple prizes.

FlaSEIA will notify winners via email provided in the submission. You will have 3 business days to acknowledge your selection as a winner by replying to the email notification. Awards will be presented at the Florida Solar & Storage Summit being held May 2-3, 2023 in Sarasota, Florida. All winners should plan to attend.
